1. The rates shall be inclusive of GST. Bidder should keep in to consideration all fluctuations in market rate and no claim be entertained due to any such variation prior to the acceptance of tender and or during currency of the contract.

  - (i) No bidder shall be permitted to tender for work if any or his relative is posted in the service of the NIH.
  - (ii) Failure on the part of the bidder to correctly or completely disclosed the names and designation as in sub clause (2) above would Tender the earnest money/the contract, if entered into shall be rescind without any claim for compensation.
  - (iii) EXPLANATION
    - (a) The expression near relatives used in this clause means father, mother, sister, brother, brother-in-law, son-in-law or mother-in-law, son-in-law, father's cousin or self, wife, son, daughter, father, mother, father-in-law or mother-in-law.
    - (b) The expression bidder or self used in this clause includes any partner or Director of the tendering firm of the company as the case may be.
  - (iv) Bidder shall submit with their tender certificates, copies of certificates of their past experience and of their having done work of their magnitude.
