I am directed to refer to the captioned subject and to say that on behalf of the Director, NIH, Roorkee proposal/quotation for annual registration of the contractor to carry out petty electrical work in NIH as and when required from time to time are invited. The detailed terms and conditions of the proposed registration of contractor shall be as per **Annexure-I**.

The contractors/firms are required to submit the quotation in a sealed cover which should be super scribed as **QUOTATION FOR REGISTRATION OF CONTRACTORS/FIRMS (ELECTRICAL WORKS)**. The other salient terms and conditions of the quotation/proposal are as under:

1. The proposals/quotations shall be submitted along with the performance security in the form of Bank Guarantee/FDR of Rs. 10,000/- in favour of National Institute of Hydrology, payable at Roorkee with the proposal/quotation, failing which the proposal will not be considered.
2. The late quotation/proposal received after the stipulated date and time received shall not be entertained.
3. Apart from the quotation/proposal the invitation to contractor along with **Annexure-I** shall be signed by the contractor on each and every page with the rubber stamp of the agency. The entire set of invitation for registration of contractor with **Annexure-I** shall be dropped in the tender box. The contractor/agency may retain a copy of the same set for his use.
4. The NIH reserves the right to accept/reject any or all the quotations/proposals and the decision of Director, NIH, Roorkee in this regard shall be final/binding.

The quotation/proposal may be dropped in the tender box placed in the office of Purchase Officer, National Institute of Hydrology, Jalvigyan Bhawan, Roorkee-247667. The due date and time for submission of the quotations/proposals is 15:00 hours on 11.01.2022. The quotations/proposals shall be opened on 11.01.2022 at 16:00 hours in the presence of bidder, who may like to be present. It may be specifically noted that the quotations/proposals are required to be submitted with the performance security in the form of Bank Guarantee/FDR for Rs.10,000/- and other required necessary documents only.

TERMS AND CONDITIONS OF THE CONTRACT RELATING TO ANNUAL REGISTRATION OF THE CONTRACTORS TO CARRY PETTY ELECTRICAL WORKS IN NIH, TIME TO TIME AS AND WHEN REQUIRED.

Eligibility Criteria

The NIH, Roorkee hereby invite sealed proposals/quotations for the registration of contractor for petty job works of maintenance/renovation of buildings and fixtures in NIH from time to time as and when required from the approved/registered contractors of CPWD/PWD/MES/CBRI Roorkee/IIT Roorkee/other Govt. organizations or Public Sector Undertakings set up by the Central or State Government to carry out electrical works. The following information/documents are required to be submitted by the contractor with proposal/quotation:

1. Copy of valid registration of contractor with CPWD, PWD, MES, CBRI Roorkee, IIT Roorkee, other Govt. organizations or Public Sector Undertakings set up by the Central or State Government to carry out electrical works.
2. Copy of PAN No. issued by the concerned income tax department
3. Copy of GST Registration.
4. Minimum turnover of the contractor will be not less than Rs. 5 lakhs per annum. A copy of Income Tax return of last 3 years should also be enclosed with their proposal/quotation.
5. Performance Guarantee in original as mentioned in Tender.

Other terms and conditions:

- i. The registration of contractors will be valid for a period of one year which can be extended up to three years by the competent authority of the Institute according to the performance of the contractor.
- ii. Non-compliance of above mentioned required information/documents, proposals/quotations will not be considered for registration.
- iii. Proposals/quotations must be received by the Institute at the address specified above not later than the time and date specified in the notice inviting proposals/quotations and the Institute will provide a receipt (inter alia containing time and date of receipt of the same).
- iv. Late proposals/quotations received by the Institute after the dead line for submission of quotation prescribed by the Institute will be rejected and/or returned to the contractor.
- v. The Institute will open proposals/quotations in the presence of bidders, representatives, who choose to attend, at the time, date and place specified in the notice.
- vi. If the specified date of quotation opening is declared as holiday for the Institute, the quotation shall be opened at the appointed time and location on the next working day.
- vii. The Institute reserve the right to accept or reject any quotation and to annul the bidding process and reject all quotations at any time prior to award of registration letter without thereby incurring any liability, what so ever, to the effected bidder/bidders.
- viii. The contractor will be entirely responsible for all taxes, duties, license fees etc. in respect of this registration of the firm, if work contract awarded to him, incurred until delivery of the contracted work.
- ix. The contractor shall be entirely responsible to follow Labour Act for engaging labour on the site of work.
- x. For any disputes, the competent authority may nominate his representative to resolve the matter. However, the court of jurisdiction will be in Uttarakhand.
